Online applications are invited from Indian Citizen and such other national as declared eligible by Government of India and who are permanent resident of West Bengal for recruitment to the post of Staff Nurse, Grade II under Health & Family Welfare Department, Government of West Bengal.

Only online registration & submission of Application will be allowed on the website (www.wbhrb.in) between 24.02.2014 to 17.03.2014 (*before* 8 PM).

Posts are temporary but likely to be permanent in future.

The relevant rules and necessary particulars are stated in the following paragraph:

A candidate should verify from the notified rules that she is eligible. The condition prescribed cannot be relaxed. The recruitment will be made by selection but where a large number of applications are received, as a result of Advertisement, the Board may , for the purpose of short-listing, hold a preliminary examination.

Scale of Pay: Rs.7100/- --- Rs.37600/-, [PB 3 , Grade Pay – Rs. 3600/-]. Other allowances will also be admissible as per existing Government Rules.

Qualification :

- Passed General Nursing & Midwifery Certificate from Nursing Training School recognized by West Bengal Nursing Council & Indian Nursing Council.

Note :

- *Must be* Registered under West Bengal Nursing Council
- *The applicant must be a Permanent Resident of West Bengal*
- *The applicant* should have the ability to read, write and speak in Bengali (not required in the case of Nepali speaking candidates of the three Hills sub-division of Darjeeling District- viz. Darjeeling sadar, Kalimpong & Kurseong).

Age : Not less than 18 Years and not more than 35 Years as on 1st. January, 2014.

Age limit relaxable by 5 years for SC and ST candidates of West Bengal, by 3 years for BC candidates of West Bengal and up to 45 years of age for persons having physical disabilities for 40% and above.

Note :

- i) Age – As recorded in Madhyamik or equivalent certificate will only be acceptable
- ii) The Director of Health Services, West Bengal is the appointing authority in respect of the Posts..

Fee : Candidates must submit the application fee amounting to Rs. 160/- (Rupees one hundred & sixty) only either by Net Banking or Offline through Bank Counter in any branch of Banks participating in the GRIPS (Govt. Receipt Portal System), Govt. of West Bengal through duplicate challan, as generated after filling up the online application Form. **Govt. Receipt Head of Account is ' 0051-00-104-002-16'.**

Money order, Cheque, Bank Draft, Cash etc. will not be acceptable.

No application will be considered unless accompanied with the requisite application fee excepting the Applicants belonging to SC/ST category of West Bengal and persons with disabilities specified under disabilities rule, 1999 (certificates obtained before the Advertisement date) who do not require to pay any fee. Such exemption of fee is, however, not applicable to any OBC (category A or B) Applicants.

No claim for refund of the fee will be entertained nor will it be held in reserved for any other examination.

Application shall be made in the format, as available ,in the West Bengal Health Recruitment Board Website (www.wbhrb.in).

Application received after the closing date shall be rejected.

In case, any of the statement made in the application be subsequently found to be false within the knowledge of the candidates- her candidature will be liable to cancellation, and even if appointed to a post on the results of this examination her appointment will be liable to be terminated. Willful suppression of any material fact will also be similarly dealt with.

Candidates should take particular note that entries in their application submitted to the Board must be made correctly against all the items which will be treated as final and no alteration and addition in this regard will be entertained after submission of the application. Application not duly filled in or found incomplete or defective in any respect or without fee will be liable to rejection.

Candidates must fulfill the qualification by the closing date. All information regarding selection/ recruitment (date of examination/ date of interview etc.) to the post will be available, time to time in the Board Website (www.wbhrb.in).

Candidates are requested to follow the WBHRB website from time to time for any update/ information.

Particulars and Certificates required:

- (a) A candidate claiming to be S.C./S.T./B.C. must have a certificate in support of her claim from a competent authority of West Bengal as specified below [vide the West Bengal SCs and STs (Identification) Act, 1994 and SCs /STs Welfare Department order No. 261-TW/EC/MR-103/94 dated 06.04.1995 read with B.C.W. Deptt. Order No. 6320-BCH/MR-84/10 dated 24.09.2010]:

- In the District, the Sub-Divisional Officer of the Sub-Division concerned, and

- ii) In Kolkata, District Welfare Officer, Kolkata & ex-officio Jt. Director, Backward Classes Welfare Department [No. 2420-BCW/MR-61/2012 (Pt.) dated 12.07.13]

(b) Persons with Disabilities (PWD) [40% and above] must have a certificate from an appropriate Medical Board [vide West Bengal Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Rules, 1999]

(c) A candidate must have a Permanent Residential Certificate/ Domicile Certificate in support of her claim from a competent authority of West Bengal as specified below :

- In case of district, except Kolkata the Competent Authority is District Magistrate/ Addl. District Magistrate/ Sub Divisional Officer of the respective district.
- In case of Kolkata, Asst. Secretary, Home (Political) Deptt., Govt. of West Bengal issues such Certificate.

(d) The West Bengal Health Recruitment Board (WBHRB), may require such further proof or particulars from the candidates as it may consider necessary and may make enquiries regarding eligibility.

Original Certificates relating to citizenship (by registration), age, qualifications, caste (SC/ST/BC), Physical disability (40% and above), Permanent Residential Certificate will have to be submitted when the WBHRB asks for them. If any candidate fails to furnish any certificate or any other relevant document or information relating to her candidature within the time specified by the Board, her claim for allotment may be passed over without further reference to her.

Full submission of more than one application is strictly forbidden. The candidature of a candidate who submits more than one application in full, for admission to the Examination, will be cancelled even if she is admitted to the same.

A candidate should note that her admission to the Examination/ Interview will be deemed provisional subject to determination of her eligibility in all respects. If at any stage even after issue of the letter of appointment a candidate is found ineligible for admission to this Examination, her candidature will be cancelled without further reference to her.

Canvassing: Any attempt on the part of candidate to enlist support for her application will disqualify her for appointment.
