Online applications are invited from Indian Citizens and such other nationals as declared eligible by the Government of India for recruitment to the posts of Tutor/Demonstrator in 47 disciplines in the cadre of *West Bengal Medical Education Service* under Health & Family Welfare Department, Government of West Bengal.

**Online Registration will be allowed on the website between 03.11.2020 to 10.11.2020 (before 8.00 P.M.).**

Posts are temporary but likely to be permanent.

**The relevant rules and necessary particulars are stated in the following paragraphs:**

A candidate should verify from the notified rules that he/she is eligible. The condition prescribed cannot be relaxed. The recruitment shall be made by selection, but where a large number of applications are received, as a result of Advertisement, the Board may, for the purpose of short-listing, hold a preliminary examination.

**Qualification (For Direct Recruitment) : Through the W.B. Health Recruitment Board among the Medical Graduates who have passed MBBS and have received the Permanent Registration No. from WBMC / MCI.**

**A) Academic & Experience :**

**Essential :**

- i) MBBS Degree from MCI recognized University in accordance with the regulation made by the Medical Council of India and included in the First or Second Schedule or Part II of the Third Schedule of the Indian Medical Council Act,1956(102 of 1956) ;

- ii) **Weightage will be given to candidates holding recognized Postgraduate Degree the disciplines under the Specialities Group and recognized Post Doctoral Degree (for disciplines under the Super Specialities Group) in the concerned discipline** in accordance with the “Minimum Qualifications for Teachers in Medical Institutions Regulations,1998” framed by the Medical Council of India, published in Part-III, Section-4 of the Gazette of India, dated the 5<sup>th</sup> day of December,1998, as subsequently amended, and which are included in the First or Second or Third Schedule of the Indian Medical Council Act,1956(102 of 1956).

**Desirable :**

- i) Publications in peer reviewed journals Indexed with Index Medicus or Journals at the National Level of the National Academic Organizations will be accepted only. 1<sup>st</sup> and 2<sup>nd</sup> author in the Publication will be considered.
- ii) Two years’ service experience in rural areas.

**NOTE :** Specialities and Super Specialities Groups respectively includes the following disciplines :

a) **Specialities Group :**

Anatomy, Physiology, Cardiac Anaesthesia, Biochemistry, Bio-Physics, Pharmacology, Pathology, Micro-biology, Community Medicine, Forensic Medicine, General Medicine, General Surgery, Obstetrics & Gynaecology, Radio-Diagnosis, Radiotherapy, Ophthalmology, Chest Medicine, Psychiatry, Dermatology, Orthopaedics, Anaesthesiology, ENT, Physical Medicine and Rehabilitation, Tropical Medicine, Nutrition & Metabolic Diseases, Virology, Immuno-haematology and Blood Transfusion, Nuclear and Experiment Medicine, Geriatrics, GI Pathology, GI Anaesthesiology, GI Radiology.

b) **Super Specialities Group :**

Cardiology, Endocrinology, Medical Gastroenterology, Neonatology, Nephrology, Neurology, Cardiovascular & Thoracic Surgery, Urology, Neuro-surgery, Paediatric Surgery, Plastic Surgery, Surgical Gastroenterology, Medical Oncology, Surgical Oncology, Haematology, Cardiac Anaesthesia and Critical Care Medicine, Rheumatology, Paediatric Gastroenterology, Neonatal Surgery.

**Explanation :** Unless specified otherwise, the expression “Recognized”, for the purposes contained in these rules, shall pertain to any medical qualification acquired/granted from a Medical College included in the First Schedule or Second Schedule or Part II of the Third Schedule of the Indian Medical Council Act,1956(102 of 1956) being either permitted under section 10A or recognized under sub-section(2) of section 11 of the Indian Medical Council Act,1956(102 of 1956)

**Age:** Not more than 45 years as on 1<sup>st</sup>. January, 2020 i.e. relaxation may be given to such doctors who have served under this State Government to an extent equivalent to the period of such service, subject to a **maximum of five years.**

Provided that age may be relaxable for the candidates belonging to the categories of SC, ST and Other Backward Classes as per Government Rules or Orders issued from time to time.

**NOTE :**

- i) Should be registered as Medical Practitioner with the West Bengal Medical Council/ Medical Council of India/ Any Recognized State Medical Council ;
- ii) Age- as recorded in Madhyamik or Equivalent Certificate will only be acceptable ;
- iii) The claim of candidates for relaxation of age as a Govt. employee should be proved by a certificate from the appropriate authority showing the period of his/her continuous service under Government and the same should be furnished when called for;

- iv) **Medical Officers of West Bengal Health Service & West Bengal Public Health-cum Administrative Service have to obtain NOC from appointing authority ;**
- v) **Candidates have to upload Photo, Signature, Medical Council Registration Certificate, and also Postgraduate/Post Doctoral Degree Certificate, if any ;**
- vi) Candidates must fulfil the essential qualifications by the closing date.

**Fee :** Candidates must submit online the application fee amounting to Rs. 210/- (Rupees two hundred ten) only through GRIPS ( Govt. Receipt Portal System ), Govt. of West Bengal under the Head of Account '0051-00-104-002-16'. **Money Order, Cheque, Bank Draft, Cash etc. shall not be acceptable.** No application shall be considered unless accompanied with the requisite application fee.

Candidates belonging to SC/ST of West Bengal and persons with disabilities specified under Disabilities Rule, 1999 (certificates obtained before the Advertisement date) are not required to pay any fee. Such exemption of fee is, however, not applicable to any OBC (category A or B) candidate.

**No claim for refund of the fee shall be entertained nor will it be held in reserved for any other examination.**

Application shall be made in the format, as available, in the West Bengal Health Recruitment Board Website ([www.wbhrb.in](http://www.wbhrb.in)).

Application received after the closing date shall be rejected.

Should any of the statements made in the application be subsequently found to be false within the knowledge of the candidates, his/her candidature shall be liable to cancellation, and even if appointed to a post on the results of this examination his/her appointment shall be liable to be terminated. Willful suppression of any material fact will also be similarly dealt with.

Candidates should take particular note that entries in their application submitted to the Board must be made correctly against all the items which shall be treated as final and no alteration and addition in this regard will be entertained after submission of the application. **Application not duly filled in or found incomplete or defective in any respect or without fee will be liable to rejection.**

Candidates must fulfill the essential qualification by the closing date. All information regarding selection/recruitment (date of examination, date of interview etc.) to the post will be available, time to time in the Board Website at [www.wbhrb.in](http://www.wbhrb.in).

**Particulars and Certificates required:**

- (a) A candidate claiming to be S.C./S.T./B.C. must have a certificate in support of his/her claim from a competent authority of West Bengal as specified below [vide the West Bengal SCs and STs (Identification) Act, 1994 and SCs /STs Welfare Department Order No. 261-TW/EC/MR-103/94 dated 06.04.1995 read with B.C.W. Department Order No. 6320-BCH/MR-84/10 dated 24.09.2010.
  - In the District, the Sub-Divisional Officer of the Sub-Division concerned, and
  - In Kolkata, the District Magistrate, South 24-Parganas, or any Additional District Magistrate, South 24-Parganas, as may be authorized by the District Magistrate, South 24-Parganas on his behalf.

***No claim for being a Member of the SC, ST and OBC or a Person with Disability will be entertained after submission of the application.***

Persons with Disabilities (PWD) [40% and above] must have a certificate from an appropriate Medical Board [vide West Bengal Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Rules, 1999]

- (b) The West Bengal Health Recruitment Board (WBHRB) may require such further proof or particulars from the candidates as it may consider necessary and may make enquiries regarding eligibility.

Original Certificates relating to citizenship (by registration), age, qualifications, caste (SC/ST/BC), Physical disability (40% and above) will have to be submitted when the WBHRB asks for them. If any candidate fails to furnish any certificate or any other relevant document or information relating to his/her candidature within the time specified by the Board, his/her claim for allotment may be passed over without further reference to him/her.

**(iii) Publications (in Index Journal) [1 per Publication] – 05 (Max.).**

**(iv) Experience in Health Service – 05 (max) ( 1Mark/year).**

***Submission of more than one application the last one will be considered and previous all candidature will be cancelled.***

A candidate should note that his/her admission to the Examination/ Interview will be deemed provisional subject to determination of his/her eligibility in all respects. If at any stage even after issue of the letter of appointment a candidate is found ineligible for admission to this Examination, his/her candidature will be cancelled without further reference to the candidate.

**Canvassing:** Any attempt on the part of candidate to enlist support for his/her application through persons, officials of Government, or agencies will disqualify him/her for appointment.
